The guarantor commits itself in paying the stated amount in the following cases:

- a) If the contracting authority withdraws or changes an offer in time of its validity, stated in the tender;
- b) If the contracting authority, which was informed about accepting of its offer by the beneficiary:
 - does not return a signed contract or information within 8 days from the receipt of the contract (sub-clause 32.3 of the Instructions)
 - does not submit the performance guarantee by the deadline defined in the sub-clause 33.1 of the Instructions.

We hereby commit to pay to the beneficiary within 15 days after the receipt of the first written claim the above amount without any additional stating of grounds, if the entitlement to this amount is due to the fulfilment of one of the above cases and the case are stated in the received claim.

The demand for payment of this guarantee shall be submitted to the guarantor and shall contain:

1. the original letter for putting into effect the guarantee in accordance to the previous indent and
2. the original of the guarantee no./..... as well as possible appendices to the guarantee.

The form of claim submission: by registered mail or any other express mail service.

This guarantee is valid until one tenderer is chosen in accordance with the above stated public tender and (in case that full or partial offer is accepted) until the moment when the chosen tenderer concludes the contract with the beneficiary and the performance guarantee is received, or if the beneficiary does not decide on the tender, until the finality of the beneficiary's decision in this tender, but at the latest until the expiration of validity of the tender.

If we do not receive any claim for payment of guarantee sum by, this guarantee shall cease to be valid and shall automatically extinguish irrespective of being returned or not.

This guarantee is not transferable.

Any disputes between the Beneficiary and the Bank shall be resolved by the court of subject matter jurisdiction in Ljubljana.
