Explanatory Note

The Bidder shall submit a request for revision to the Purchaser, and send its copy also to the ministry responsible for finance, Public – Private Partnership Division and Public Procurement System. The request for revision shall be submitted by registered post with acknowledgement of receipt or in electronic form if verified with qualified certificate.
